The terms hereof shall serve as a release and assumption of risk for my heirs, estate, executor administrator, assignees, and, all members of my family. I hereby agree to submit any disputes that may arise between myself and UD, its agents, servants, trustees and employees, in connection with my activities at UD, to binding arbitration before three arbitrators, in accordance with the rules of the American Arbitration Association.
